

Turtle Beach *DreamHack London* Giveaway

Official Rules

NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN. PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

1. Eligibility: Turtle Beach *DreamHack London* Giveaway (the "Giveaway") is open to legal residents of the United Kingdom who are 16 years of age or older at the time of entry. Employees of Turtle Beach Corporation ("Sponsor"), and its parent companies, subsidiaries, affiliates, agents and those prize providers and agencies that are involved in the development or execution of the Giveaway or any of its materials, and the immediate family (spouse, parents, siblings, and children) and household members of each such person are not eligible. The Giveaway is subject to all applicable local laws and regulations and is void where prohibited by law.

2. Sponsor: The Giveaway is sponsored by Turtle Beach Corporation 2200 Renaissance, Basing View, Basingstoke, Hampshire, RG21 4EQ. DreamHack has provided certain prizes but is in no way involved in the creation, execution, administration or fulfillment of the Giveaway.

3. Agreement to Official Rules: By participating in the Giveaway, entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of the Sponsor, which are final and binding in all matters related to the Giveaway.

4. Promotion Period: The Giveaway begins at 12:01pm on Thursday, September 17, 2015 and ends at 12:01 PM on Friday, September 18, 2015 (the "Giveaway Period"). Sponsor's computer is the official time-keeping device for the Giveaway.

5. How to Enter: During the Giveaway Period, visit www.turtlebeachlive.com and follow the instructions to submit your entry. All entries must be received by during the Giveaway Period to be eligible. There is a limit of one (1) entry per person, household, and email address throughout the Giveaway Period. Entries must be completed in full and submitted by the entrant him/herself to be eligible.

Any attempt by an entrant to obtain more than one (1) entry during the Giveaway Period by using multiple/different email addresses, devices, identities, registrations or logins, or any other methods will void such entrant's entries and such entrant may be disqualified from the Giveaway. Any use of robotic, repetitive, automatic, programmed or similar entry methods or agents (including, but not limited to, Giveaway entry services) will void all entries by an entrant. In the event of a dispute as to any entry, the authorized account holder of the phone number or email address used to enter will be deemed to be the entrant. Entries that do not comply with the Official Rules as determined by the Sponsor, in its sole discretion, may be disqualified and may not be considered for prizes. Sponsor makes the final determination as to which entries are eligible to take part in the Giveaway and be considered for a prize.

6. Prize Drawings: Fifteen (15) random drawings, from all eligible entries received, will be conducted by the Sponsor on September 18, 2015. Odds of winning depend on the number of eligible entries received. The potential prize winners will be notified by email. Prizes will be awarded and shipped using

information submitted during the entry process. No changes to any of the submitted information can be changed after entry. Decisions of Sponsor and its agents are final and binding and may not be appealed.

7. Prize: One ticket to attend DreamHack London Event, 19th-20th September 2015

All prize details are determined by Sponsor, in its sole discretion. No substitution, exchange or transfer of any prize by a winner. Sponsor reserves the right to substitute or cancel prizes at any time. Each prize winner is responsible for all taxes and fees associated with prize receipt and/or use. Limit of one (1) prize per entrant. Winners will not be able to substitute prizes for cash value.

8. Publicity; Use of Personal Data: Except where prohibited, participation in the Giveaway constitutes entrant's consent for Sponsor and its affiliates and/or designees to use entrant's name, prize information, likeness, city and state of residence for promotional and/or marketing purposes in any media without further consideration. By participating in the Giveaway, each entrant consents and authorizes the use and collection of his or her e-mail address for the purpose of adding such e-mail address to marketing list(s) any other purposes to which you have consented. 9. General Conditions: Sponsor reserves the right in its sole discretion to cancel the Giveaway at any time. In the event that the operation, security, or administration of the Giveaway is impaired in any way for any reason, including, but, not limited to, fraud, virus or other technical problem, the Sponsor may, in its discretion, either: (a) suspend the Giveaway to address and/or modify the impairment and then resume the Giveaway in a manner that best conforms to the spirit of these Official Rules; or (b) cancel the Giveaway and award the prizes in a random drawing from among all eligible entries received up to the time of impairment. The Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Giveaway or to be acting in violation of the Official Rules of this or any other promotion, or in an unsportsmanlike or disruptive manner. Any attempt by any person to undermine the legitimate operation of the Giveaway may be a violation of criminal and civil law, and, should such an attempt be made, the Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. The Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

10. Release and Limitations of Liability: Except where prohibited, by participating in the Giveaway, entrants agree to release and hold harmless Sponsor and its parents, subsidiaries, limited liability and affiliate companies, promotional partners, prize partners, agents and agencies, and the shareholders, officers, directors, members, and employees of them (the "Released Parties") from and against any claim or cause of action arising out of participation in the Giveaway or receipt or use of any prize, including, but not limited to: (a) unauthorized human intervention in the Giveaway; (b) technical errors related to computers, servers, providers, printers, cellular networks, or telephone or network lines; (c) printing errors; (d) errors in the administration of the Giveaway or the processing of entries; (e) late, lost, or undeliverable mail; or (f) injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Giveaway or receipt of any prize. Entrant further agrees that in any cause of action, the Released Parties' liability will be limited to the cost of entering and participating in the Giveaway and in no event shall the Released Parties be liable for fees.

Entrant waives the right to claim any damages whatsoever, including, but not limited to, punitive, consequential, special, direct, or indirect damages. If, for any reason, an entrant's entry is confirmed to have been erroneously deleted, lost, or otherwise destroyed or corrupted, entrant's sole remedy is another Giveaway entry, if it is possible. If the Giveaway, or any part of it, is discontinued for any reason, Sponsor, at its discretion, may elect to hold a random drawing from among all eligible entries received up to the date of discontinuance for any prize offered herein. No more than the stated number of prizes will be awarded. In the event that production, technical, seeding, programming or any other reasons cause more than the stated number of prizes as set forth herein to be available and/or claimed, Sponsor reserves the right to award only the stated number of prizes by a random drawing among all legitimate, un-awarded, eligible prize claims.

11. Disputes: Entrant agrees that: (a) any and all disputes, claims and causes of action arising out of or connected with the Giveaway or any prizes awarded shall be resolved individually, without resort to any form of class action, and exclusively by the courts of the United Kingdom; and (b) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering any Giveaway, but in no event attorneys' fees. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and Sponsor in connection with the Giveaway, shall be governed by, and construed in accordance with, the laws of the United Kingdom, without giving effect to any choice of law or conflict of law rules, which would cause the application of the laws of any jurisdiction other than the United Kingdom.
